

The regular meeting of the State Board of Barber Examiners was held at 8:00 at New Tyler Barber College, North Little Rock, AR on June 10, 2019.

The following board members were present: Tom McArthur, Ricky Bryant, Julius Odom, and Mary Fisher. Those who attended the meeting were Michael L Wooldridge, Phyllis Jacobsen, Ed Jordan and Jeannie McArthur.

Tom McArthur declared a forum and called the meeting to order.

Tom McArthur read the previous month's minutes and Ricky Bryant made the motion to accept as read, with a Mary Fisher second, the motion was approved.

Dion Simpson has still not paid his fine. The attorney general representative, Brad Nye, is going to get with his superior to file in civil court an action to have him either pay the fine or go to court.

We still have not heard anything from The Smith Barber Institute as to when he wants his final inspection. We are waiting for Wilbert Easterling who has an approved school in Dermott to let us know when he wants his final inspection. Legendary Institute by Vinson Joiner in Little Rock is now working on his plumbing. It awaits inspection also.

Ed Jordan, inspector, will be able (after his second attempt to correct an issue with a shop or a barber) upon the second infraction to give them an opportunity to sign a Consent Agreement.

New business: Our barber renewals: We are still at a total of 3645. Of those 2719 are current. We have over 1009 shops. Since 2015 we have collected \$4150 in fines. \$2450 of that is this fiscal year.

The performance reviews have been completed and will be effective June the 15th.

The National Association of Barber Boards is going to be held in Reno, Nevada, September 15th through the 19th, and a motion to allow Mr. Wooldridge to attend that meeting was made by Ricky Bryant and Tom McArthur seconded, the motion was approved. Tom McArthur made a motion the board members be allowed to go if they chose so, and to let the board know by August 1st, 2019. Ricky Bryant seconded. The motion was approved.

The Arkansas legislative audit exit interview was last Friday, June the 7<sup>th</sup>, and the board had no reportable findings.

We have a board member to be appointed on June the 30<sup>th</sup> as Ricky Bryant's term is up. He has reapplied and has been recommended by several people to be reappointed.

Tom McArthur made a motion that our TMI make up training and next board meeting be July 15<sup>th</sup>, 2019 at Arkansas College. Julius Odom seconded. The motion was passed.

The TMI make up training will have the instructors sit through our next board meeting. They will skirt each one of the board members as they do the examination of the haircuts of the students. They will also sit in on the grading of the written examinations. They are going to take the student examination test as well. After a break in the afternoon, we are going to go over all the laws and rules and how these are implemented, and the procedure that we go through.
