

The regular meeting of the State Board of Barber Examiners was held at 8:00 at Arkansas College of Barber and Hair Design, Little Rock, AR on September 16, 2019.

The following board members were present: Tom McArthur, Ricky Bryant, Mary Fisher and Rex Bailey. Others who attended the meeting were Phyllis Jacobsen, Ed Jordan, Brad Nye and DeNise Myers.

Tom McArthur declared a forum and called the meeting to order.

Tom McArthur read the previous month’s minutes and Rex Bailey made the motion to accept as read. With a Tom McArthur second, the motion was approved.

In accordance with the statues the Board meeting is being recorded. If you speak, indicate your name and everybody try to maintain quiet so that the recorder can pick up everyone’s name as they speak.

A discussion of old business included pending schools, including Legendary Institute on Bowman road and Wilbert Easterling’s school in Dermott.

The board had two felons who were approved per Act 990.

We are required by Act 426 to issue a Temporary and Provisional License to those barbers applying for reciprocity from an area that has similar requirements for licensure as the state of Arkansas. We have issued three temporary licenses to barbers who will take October Board.

Ed Jordan is now full time with Secretary Bassett’s approval. The Board voted last month to add an additional inspector after appropriation requests have been approved by Bassett.

Rex Bailey stated that he called Phyllis Jacobsen and thanked her for her efforts on our audits. That will go a long way in helping us with our credibility. It’s very important that all our audits come back good and I appreciate her.

A discussion was held regarding the school owners meeting with Mr. Wooldridge. Ricky Bryant led the discussion since he was at the school owners meeting this past week. A few topics came up that Secretary Bassett talked about with Mr. Wooldridge pertaining to being proactive on reducing hours and getting students in the workplace quicker. No decision was made, and further discussion will be held when Mr. Wooldridge returns from the national meeting.

Next board meeting will be October 21, 2019 at New Tyler Barber College, North Little Rock, Arkansas.

No applicants will be graded by board members who know or have taught the applicants. It takes two board members to fail a student on their practical examination.

Rex Bailey made the motion to adjourn, seconded by Ricky Bryant, the motion carried.
